

## Privacy Policy

This Privacy Policy ("Policy") applies to [www.garagearmorct.com](http://www.garagearmorct.com), and Garage Armor CT ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [www.garagearmorct.com](http://www.garagearmorct.com). The Company's website is a An epoxy flooring company site. By using the Company website, you consent to the data practices described in this statement.

### Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address
- Email address
- Phone number
- Scope of work details pertinent only to providing service estimates and contracts.

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ### **Sharing Information with Third Parties**
